Dear Council members, the waster water fee increase being presented at first reading at Council tonight is much too important and has too many unanswered questions to move forward in it's present form. Just the fact of the lack of details on where the money goes in the Platte to Park Hill part of the plan, now estimated at \$206 (and a plan that was NOT included in the 2014 waste water master plan) is enough to slow down and decide if this entire plan should be approved, or if only parts should move ahead.

So here would be my two options for amending the bill, something that any of you could propose tonight:

1) Put a hold on the bill until an INDEPENDENT assessment could be done of waste water and drainage needs in the city, as opposed to those that are to benefit the proposed I-70 ditch.

Currently the City's waste water dept, that has to answer to Mayor "Corridor of Opportunity" Hancock and CDOT, who has to answer to Governor "My Way is Only the Highway" and P3 keynote speaker Hickenlooper are the only agencies making the evaluation of these needs. Doesn't it make sense for a proposed increase of this magnitude to have an outside objective opinion??

2) At the least, amend the bill to take out the \$206 million Platte to Park Hill drainage project and let the rest of the increase go thru.
