The rescissions from agency General Fund are possible due to 2024 year-end savings. The rescission and appropriations will support the following:

- CPD is requesting to transfer savings to the TS capital Innovation Fund to fund the develop of AI-powered plan review permitting software designed to significantly reduce plan review times and enhance compliance accuracy. Alongside this, CPD will aim to modernize applications interface by introducing a user-friendly permitting wizard, which could potentially reduce permitting times by 50%.
- DPR requests to transfer to the Planned Capital Equipment is to support the purchase of three 15ft Mowers, Small Turf Equipment, two Small Mowers, and Cardio and Weight Equipment for recreation centers.

This bill authorizes the purchase of the following capital equipment over the \$50 threshold out of the Planned Capital Equipment SRF to support Denver Parks and Recreation Operations:
