## FIRST AMENDATORY AGREEMENT

THIS FIRST AMENDATORY AGREEMENT is entered into this \_\_\_\_\_\_ day of \_\_\_\_\_, 2011 by and between the CITY AND COUNTY OF DENVER, a Colorado municipal corporation ("City"), Party of the First Part, and ISS FACILITY SERVICES INC., a Texas corporation authorized to do business in Colorado ("Contractor"), Party of the Second Part.

## WITNESSETH

WHEREAS, the parties entered into an Agreement dated April 7, 2009 ("Existing Agreement") wherein the Contractor agreed to provide window washing services for Denver International Airport; and

WHEREAS, the parties desire to amend the Existing Agreement to increase the maximum contract liability;

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

1. Paragraph 4.03 "MAXIMUM LIABILITY" of the Existing Agreement is hereby amended by deleting the said paragraph in its entirety and replacing it with the following:

## "4.03. MAXIMUM LIABILITY:

Any other provision in this Contract notwithstanding, in no event shall the City be liable for payment under this Contract for any amount in excess of Six Million Seven Hundred Fifty- Nine Thousand Nine Hundred Dollars (\$6,759,900.00). The Maximum Contract Liability may only be increased by amendment to this Contract. All payments under this Contract shall be paid solely and exclusively from the City's "City and County of Denver, Airport System and Operation and Maintenance Fund" and from no other fund or source. The City is under no obligation to make any future apportionments or allocations to said fund."

- 2. Except as otherwise provided herein, all of the terms, provisions and conditions of the Existing Agreement shall remain in full force and effect as though set out in full herein.
- 3. This First Amendatory Agreement shall not be effective or binding on the City until fully executed by all signatories of the City and County of Denver.
