FIRST AMENDMENT TO SOLAR POWER PURCHASE AGREEMENT

This First Amendatory Agreement ("First Amendment") is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City") and MMA CCC POWER, LLC, a Delaware limited liability company doing business at 330 Congress Street, 6th Floor, Boston, MA 02210) ("Power Provider"), collectively, (the "Parties").

WITNESSETH

WHEREAS, the Parties executed a certain Solar Power Purchase Agreement dated as of June 10, 2008 (the "Agreement");

WHEREAS, pursuant to the Agreement, the Parties agreed that Power Provider would design and supply a grid-interconnected, ground mounted or roof-top solar electric PV system (the "System");

WHEREAS, the City agreed to purchase from Power Provider the entire energy output of the System; and

WHEREAS, the Parties desire to amend the Agreement by means of this First Amendment to modify the notices provision and amend Exhibit C, the purchase price.

NOW, THEREFORE, in consideration of the promises and the mutual benefits from the agreements hereinafter set forth and other good and valuable consideration, the sufficiency of which is hereby acknowledged by the Parties, the City and Power Provider agree to the following amendments to the Agreement (all section references are to sections of the Agreement):

- 1. Exhibit C of the Agreement is hereby amended by deleting years 11 through 25 and replacing them with the table on Exhibit C-1 attached hereto.
- 2. Section 32 of the Agreement is amended by deleting Power Provider's notice information and replacing it with the following:

- 4. Except as modified by the provisions of this First Amendment, all other terms and conditions in the Agreement, remain in full force and effect.
- 5. In the event of any conflict, inconsistency, variance or contradiction between the provisions of this First Amendment and any provisions of the Agreement, the provisions of this First Amendment shall in all respects supersede, govern and control.
- 6. This First Amendment will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
