A BILL

For an ordinance repealing and reenacting Sections 15-16 and 15-17 of the Revised Municipal Code to update the precinct plans and remove obsolete precincts for city council districts.

WHEREAS, pursuant to Sections 8.1.2 (E) and (F) the Clerk and Recorder is vested with exclusive authority for the conduct of elections, and will perform such other duties as may be required by the charter or by ordinance; and

WHEREAS, the current council district boundaries, approved by Ordinance No. 337, Series of 2002, were originally established and, in accordance with the charter, consisted of whole election precincts at the time of their establishment; however, since 2002, subsequent reconfigurations of precincts in accordance with state law have required a reassignment of precinct designations in the current districts; and

WHEREAS, the Elections Division has reviewed the precinct plans for the council districts set forth in Sections 15-16 and 15-17 of the Revised Municipal Code and has determined certain adjustments are necessary to update the precinct plans; and

WHEREAS, this bill updates the precinct plan for the current districts contained in Section 15-16 of the Revised Municipal Code by removing obsolete precincts and providing a transitional precinct plan in the event of a municipal election prior to the May 7, 2015, municipal general election; and

WHEREAS, this bill updates the precinct plan contained in Section 15-17 of the Revised Municipal Code by making adjustments to precincts due to changes in population; and

WHEREAS, the revised precinct plans are each shown separately on a city-wide Council District map, prepared by the Elections Division of the Clerk and Recorder’s Office, establishing the precincts within the current district boundaries and the 2015 district boundaries for all eleven (11) individual City Council districts;

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

SECTION 1. That Section 15-16 of the D.R.M.C., is hereby repealed and reenacted as follows:

Sec. 15-16. Boundaries and Precinct Plan for the council districts for municipal elections conducted before May 7, 2015.

1 Effective for any municipal election conducted before the May 7, 2015, municipal general
 2 election, the precincts for the eleven (11) council districts shall be as described below. The
 3 boundaries of the council districts, as approved by the City Council in Ord. No. 337, Series of
 4 2002, and the boundaries of the precincts described below are depicted on the council district and
 5 precinct map on file in the office of the clerk and recorder at City Clerk Filing No. 2014-0283.

22 **Sec. 15-17. Boundaries and Precinct Plan for the council districts for the municipal general**
 23 **election on May 7, 2015, and thereafter.**

24 Notwithstanding section 15-16 above, effective for the May 7, 2015 municipal general
 25 election, and for any municipal election to be held thereafter, the precincts for the eleven (11)
 26 council districts shall be as described below. The districts shall consist of whole election precincts.
 27 The boundaries of the council districts, as approved by the City Council in Ord. No. 242, Series of
 28 2012, and the boundaries of the precincts described below are depicted on the council district and
 29 precinct map on file in the office of the clerk and recorder at City Clerk Filing No. 2014-0286 and
 30 City Clerk Filing No. 2014-0286-A.
