2017 General Obligation Bond Process

2016: Input Phase

- Gather and evaluate list of potential projects
- Elevate 2020 (Six Year Capital Improvement Plan)
- City-owned cultural institutions & Denver Health
- City council and public (November-December)

2017: Evaluation and Recommendation Phase

- External stakeholder committees (March-April)
- Project list presented to the public (spring)
- Project list submitted to Denver City Council for referral to November 2017 ballot (summer)



Summary of Input Received

- Over 3,000 comments received during the public engagement phase.
- Over half the comments received were related to transportation and mobility project ideas.

Summary of Project List

- Project ideas from the public, Council, agencies and the Six-Year plan have been summarized into single list and can be viewed on the following website: http://www.denvergov.org/2017gobond
- All comments were reviewed for eligibility, triaged, & translated (where needed).
- Non-GO bond eligible projects included projects that:
 - Were not a capital project (operating programs and services)
 - Were not part of a city-owned asset (e.g., Denver Public School)
 - Did not serve a governmental purpose
 - Did not have an expected useful life of at least 10 years
 - Enterprise fund capital projects (drainage, golf, airport)
- All project input summary has been shared with departments, including project ideas that were not eligible for GO bond funding.



External Stakeholder Committees Structure



- Executive Committee is composed of a chair, 2 co-chars, subcommittee chairs, 5 community appointments, City Council President, Chief & Deputy Chief Projects Officers, City Attorney, Chief Financial Officer, & Capital Program Manager.
- Subcommittees are composed of a chair, a City Council representative, between seven (7) and fifteen (15) community appointments, a staff member from the Mayor's Office, Office of Sustainability and other internal city agency representatives.



External Stakeholder Committees Roles and Responsibilities

- City agencies will present priority Six-Year Plan projects to the committees to explain scope, cost, and maintenance considerations, etc.
- Cultural institutions are responsible for presenting their projects to the Arts and Culture subcommittee
- GO Bond team will present the project ideas from the public and City Council, providing the same information as listed above
- Subcommittees will review project list and provide a recommended package of improvements to the Executive Committee
- Executive Committee will review project packages from each subcommittee and recommend a package of improvements to the Mayor



External Stakeholder Committees Roles and Responsibilities

- Each committee will be provided foundational criteria that primarily focuses on:
 - Project readiness
 - Bond funding eligibility (e.g., serves a government purpose, 10 year useful life, etc.)
 - Equity (geographic, socioeconomic, health, etc.)
 - Cost considerations
 - Critical system needs (e.g., deferred capital maintenance)
- Additional criteria
 - Secondary criteria to be provided based on themes such as safety, accessibility, mobility, economic development, recreation and cultural opportunities, and sustainability, etc.
 - Each committee will be responsible for developing additional criteria that are specific to their committee (e.g., safety response times for safety facilities).



Key Schedule Milestones

- Committee meetings will be kicked off the week of March 13th and will be held through early May
 - Meeting dates, frequency, duration, etc. will be determined by each committee
 - Subcommittees will recommend a package of improvements to the Executive Committee around the end of April
 - Executive Committee will recommend a package of improvements to the Mayor in early May
- Final recommended package of improvements will be communicated to the public in May/June
- City Council will consider the final package of improvements in July/August for referral to the 2017 November ballot
