4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**  
6 **of land as East 8th Avenue, located at the intersection of East 8th Avenue and**  
7 **North Dahlia Street.**

8 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of  
9 the City and County of Denver has found and determined that the public use, convenience and  
10 necessity require the laying out, opening and establishing as a public street designated as part of  
11 the system of thoroughfares of the municipality that portion of real property hereinafter more  
12 particularly described, and, subject to approval by resolution has laid out, opened and established  
13 the same as a public street;

14 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That the action of the Executive Director of the Department of Transportation  
16 and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of  
17 the municipality the following described portion of real property situate, lying and being in the City  
18 and County of Denver, State of Colorado, to wit:

20 **LAND DESCRIPTION – STREET PARCEL**

21 A PARCEL OF LAND CONVEYED BY SPECIAL WARRANTY DEED TO THE CITY AND COUNTY  
22 OF DENVER, RECORDED ON THE 14TH DAY OF NOVEMBER, 2023, AT RECEPTION  
23 NUMBER 2023109306 IN THE CITY AND COUNTY OF DENVER CLERK AND RECORDER’S  
24 OFFICE, STATE OF COLORADO, DESCRIBED AS FOLLOWS:

25 THE SOUTH 8.00 FEET OF LOT 24, BLOCK 7, OLMSTED & CHAMBERLAIN’S COLFAX PARK,  
26 EXCEPT THE EAST 8.00 FEET TO THE CITY RECORDED IN BOOK 6110 AT PAGE 489,  
27 SITUATED IN THE SOUTHEAST QUARTER OF SECTION 6, TOWNSHIP 4 SOUTH, RANGE 67  
28 WEST OF THE 6TH PRINCIPAL MERIDIAN, CITY AND COUNTY OF DENVER, STATE OF  
29 COLORADO.

30 CONTAINING 1,017 SQUARE FEET, (0.023 ACRES), MORE OR LESS

34 as East 8th Avenue.
