This is a first amendment to agreement, which is not listed on the 90-Day Forecast. Further details are provided in Paragraph D below.

B. **Memorandum No. 8B to Mayoral Executive Order No. 8** (Justification for deviation from Competitive Selection Policy, e.g. for Non-Competitive Process, Term > 3 Years, and Amendments)

For continuity of service, we are amending the existing agreement to add to the maximum contract liability. Nossaman was originally selected due to their reputation in the Public Private Partnership (P3) community, experience with similar projects, and ability to use precedent projects and agreements to efficiently work through the short and intense predevelopment phase.

#### C. Selection Process Details or Other Related Actions

This is a first amendment to the original agreement. This procurement was originally solicitated through a Request for Qualifications (RFQ) competitive selection process.

D. Provide in detail the Scope of Work, Agreement, Amendment, or Project (Explain any changes in the term)

Airport Legal Services (ALS) identified the need for assistance from outside counsel during the predevelopment phase of the Great Hall Project. From a legal perspective, the 6-month phase will mean drafting and negotiating a complex Development Agreement that will govern the P3 for the next +/- 30 years. Though ALS attorneys will be deeply involved in this process, outside expertise in P3 transactions is needed, as well as additional bandwidth.

- Advise the City on all aspects of the Development Agreement, including the structure of the Agreement and the implications of various deal points and proposed terms
- Assist the City in negotiations with the private developer, which will include participation in face-to-face meetings with the private developer and its counsel
- Assume primary drafting responsbility for the Development Agreement
