

SECOND AMENDATORY AGREEMENT

THIS SECOND AMENDATORY AGREEMENT is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”), and **CENTURYLINK SALES SOLUTIONS, INC.**, a Delaware corporation, whose address is 100 CenturyLink Drive, Monroe, Louisiana, 71203 (the “Contractor”), individually a “Party” and collectively the “Parties.”

WHEREAS, the Parties entered into an Agreement dated July 13, 2022, to provide the City with telephony, telecommunications, and internet services (the “Agreement”); and

WHEREAS, the Parties now wish to modify the Agreement as set forth below.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties incorporate the recitals set forth above and amend the Agreement as follows:

- 1.** Effective upon execution, all references to Exhibit A in the existing Agreement shall be amended to read Exhibits A and A-1, as applicable. Exhibit A-1 is attached and will control from the date of execution.
- 2.** Except as amended here, the Agreement is affirmed and ratified in each and every particular.
- 3.** This Second Amendatory Agreement is not effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
- 4.** The following attached exhibits are hereby incorporated into and made a material part of this Agreement: **Exhibit A-1**, Service Attachments.

AMENDMENT TO SERVICES

This Amendment is between **CenturyLink Sales Solutions, Inc.** or its affiliated entities (“Contractor” or “CenturyLink”) and **CITY AND COUNTY OF DENVER** (“City”). It amends the applicable Services Agreement, as determined by Lumen records and as may have been previously amended (the “Agreement”). It is effective on the date the last party signs it (the “Amendment Effective Date”). This Amendment provides the terms and conditions applicable to Customer’s purchase of products and services identified in this Amendment (“Services”) from CenturyLink. Except as set forth in this Amendment, capitalized terms will have the definitions assigned to them in the Agreement. CenturyLink may withdraw this offer if Customer does not execute and deliver the Agreement to CenturyLink on or before December 31, 2023 (“Cutoff Date”).

1. Modifications to Pricing.

1.1 The following section is being added to the existing Domestic Voice Service Exhibit Pricing attachment:

Pre-subscribed Interexchange Carrier Charge. Provided Customer is otherwise in compliance with this Agreement, CenturyLink will waive one hundred percent (100%) of the per line MRC (maximum \$3.99 per line) for the Pre-subscribed Interexchange Carrier Charge (“PICC”) (also known as the Access Line Charge) for multi-line business lines and Centrex lines (“PICC Waiver”). Such PICC Waiver will only be valid throughout the Initial Term as Services are installed by Customer.

1.2 The rates for Internet Services set forth in the PRICING ATTACHMENT of the INTERNET SERVICES SERVICE SCHEDULE are amended to:

(a) Delete and replace all existing rates with the tables below. All previous rates and/or locations are deleted and replaced.

Digital signatures and electronically exchanged copies of signed documents will be sufficient to bind the parties to this Agreement.
