#### RECITALS

- A. Licensor is the owner of that certain real property, together with the improvements located thereon, located at several sites in Denver, Colorado, as more particularly described on Exhibit A, attached hereto and incorporated herein (collectively, the "Property").
- B. Licensee developed a bicycle sharing system for Denver, Colorado (the "<u>Bike</u> Sharing System").
- C. Licensee desired to locate a microprocessor controlled locking bicycle rack and kiosk with bicycles (collectively, the "<u>Bike Station</u>") on the portion of the Property shown on Exhibit B, attached hereto and incorporation herein (the "<u>Licensed Area</u>").
- D. Licensee and Licensor entered into a License Agreement dated February 23, 2010 (the "License Agreement") to accomplish the licensing of the Licensed Area for Bike Stations within the City's Property for the Bike Sharing System.
- E. Licensee and Licensor now wish to amend the License Agreement to add an additional Licensed Area located at the City's new Justice Center.
- NOW, THEREFORE, in consideration of the premises, the mutual agreements herein contained, and subject to the terms and conditions hereinafter stated, it is hereby understood and agreed by the parties hereto as follows:
- 1. Exhibit A is hereby replaced in its entirety by Exhibit A-1, attached hereto and incorporated herein. All references to Exhibit A in the License Agreement are hereby amended to refer to Exhibit A-1.
- 2. Exhibit B is hereby replaced in its entirety by Exhibit B-1, attached hereto and incorporated herein. All references to Exhibit B in the License Agreement are hereby amended to refer to Exhibit B-1. Pursuant to section 7 of the License Agreement, Licensee has added to Exhibit B-1 the square footage of the Licensed Areas as a description of the footprint including the dimensions thereof.

- 3. Exhibit C is hereby replaced in its entirety by Exhibit C-1, attached hereto and incorporated herein. All references to Exhibit A in the License Agreement are hereby amended to refer to Exhibit C-1.
- 4. Except as amended herein, the Agreement is reaffirmed and ratified in each and every particular.
- 5. The Amendatory License Agreement may be executed in two (2) counterparts, each of which is an original and constitute the same instrument.



### EXHIBIT A-1

#### THE PROPERTY

- 14<sup>th</sup> and Larimer: The station will be located in what is currently the grassy area adjacent to the west side of the CU Denver Building between 14<sup>th</sup> St. and Speer Blvd.
- 18<sup>th</sup> and Arapahoe: The station will be located along the interior of the "C" shaped wall on the north west corner of 18<sup>th</sup> and Arapahoe.
- Cherry Creek Mall: The station will be located on the south side of Cherry Creek Mall, just north of the fountain in the large oval shaped area bordered by green fencing along the Cherry Creek Trail.
- Commons Park: The station will be located along the retaining wall directly east of the south entrance to Commons Park.
  - Convention Center at 14<sup>th</sup> and Champa: The station will be located directly north of the landscaping found on the southwest corner of 14<sup>th</sup> and Champa.
  - Convention Center at 14<sup>th</sup> and Welton: The station will be located where the current "Convention Center" sign resides on the northwest corner of 14<sup>th</sup> and Welton
- Denver Botanic Gardens: The station will be located on the west side of York St., between the sidewalk and the fence, in the area between the bus stop and the gated entrance to the facility.
  - Denver Public Library: The station will be located on the south side of the west entrance of Denver Public Library.
  - Webb Building: The station will replace the current bike station which resides adjacent to the west entrance of the Webb building in the plaza area.
- 14<sup>th</sup> and Elati: The station will be located directly north of the current "City and County of Denver Justice Center" sign, replacing the current bike racks, which will be relocated on the property.


Cherry Creek Mall: Footprint is 261 square feet

Convention Center at 14<sup>th</sup> and Champa: Footprint is 315 square feet









Proposed station orientation follows:



**18**<sup>th</sup> and Arapahoe - At no cost or expense to Licensor, Licensee or its contractor shall be responsible for preparing, in cooperation with the Licensor, the Licensed Area for the installation of the Bike Station in accordance with the site readiness criteria set forth in <u>Exhibit D</u>, attached hereto and incorporated herein. Proposed station orientation follows:



**Cherry Creek Mall** - At no cost or expense to Licensor, Licensee or its contractor shall be responsible for preparing, in cooperation with the Licensor, the Licensed Area for the installation of the Bike Station in accordance with the site readiness criteria set forth in <u>Exhibit D</u>, attached hereto and incorporated herein. Proposed station orientation follows:

Webb Building - At no cost or expense to Licensee, Licensor shall be responsible for preparing the Licensed Area for the electrical installation of the Bike Station in accordance with the site readiness criteria set forth in <a href="Exhibit D">Exhibit D</a>, attached hereto and incorporated herein. At no cost or expense to Licensor, Licensee or its contractor shall be responsible for preparing, in cooperation with the Licensor, the Licensed Area for the foundational installation of the Bike Station in accordance with the site readiness criteria set forth in <a href="Exhibit C">Exhibit C</a>, attached hereto and incorporated herein.
