REDISTRICTING

A BILL

For an ordinance amending Article II of Chapter 15 of the Revised Municipal Code for purposes of approving a new redistricting plan for the eleven council districts of the City and County of Denver for the municipal election on May 7, 2015, and for any general or special council election held thereafter.

Whereas, Section 3.1.2 of the Charter of the City and County of Denver requires the City Council to adjust the boundaries of the eleven Council districts at least once every ten years based upon the most recent United States decennial census or other official population studies; and

Whereas, Section 3.1.2 of the Charter of the City and County of Denver requires that the City's population be as evenly divided between the eleven Council districts as possible and that the districts be as compact as possible and contain contiguous territory; and

Whereas, Section 3.1.2 of the Charter of the City and County of Denver requires that the eleven Council districts be comprised of whole election precincts; and

Whereas, Ordinance No. 337, Series of 2002, adopted the current Council district boundaries, effective May 1, 2002, nearly ten years ago, for the next municipal election on May 6, 2003; and

Whereas, Council Resolution CR11-661 establishes April 29, 2012, as the date by which Council plans to pass an ordinance adopting new Council district boundaries; and

Whereas, Council has established new district boundaries based on all legal requirements and its own principles as outlined in Resolution CR11-0661.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That a new section 15-17 of Article II of Chapter 15 of the Denver Revised Municipal Code is hereby adopted to read as follows:

Sec. 15-17. Boundaries for the municipal election on May 7, 2015, and thereafter. Notwithstanding section 15-16 above, effective for the general municipal election May 7, 2015, and for any general or special council election to be held thereafter, the boundaries of the eleven council

1 districts shall be as described below. The districts shall consist of whole election precincts as depicted
2 on the precinct map approved by the Denver Clerk & Recorder on January 6, 2012, and the district
3 boundaries shall be as depicted on the map on file in the office of the clerk and recorder at Clerk's
4 Filing Number 12-284.
