5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as North Yates Street, located near the intersection of North Yates Street**
7 **and West 13th Avenue.**

8 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of
9 the City and County of Denver has found and determined that the public use, convenience and
10 necessity require the laying out, opening and establishing as public streets designated as part of the
11 system of thoroughfares of the municipality those portions of real property hereinafter more
12 particularly described, and, subject to approval by resolution has laid out, opened and established
13 the same as a public street;

14 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That the action of the Executive Director of the Department of Transportation
16 and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of
17 the municipality the following described portion of real property situate, lying and being in the City
18 and County of Denver, State of Colorado, to wit:

15 THENCE CONTINUING ALONG SAID WEST LINE, SOUTH 00° 00' 01" EAST, A DISTANCE OF
16 50.64 FEET TO THE INTERSECTION OF SAID WEST LINE OF NORTH YATES STREET WITH
17 THE NORTH LINE OF WEST WELLS PLACE AS DESCRIBED IN ORDINANCE NO. 798, SERIES
18 2005 RECORDED AT RECEPTION NO. 2005190432;
19 THENCE ALONG THE NORTH LINE OF SAID WEST WELLS PLACE, SOUTH 89° 59' 55" WEST,
20 A DISTANCE OF
21 1.00 FOOT;
22 THENCE DEPARTING SAID WEST LINE ON A LINE PARALLEL TO AND 1.00 FOOT WEST OF
23 SAID WEST LINE OF NORTH YATES STREET, NORTH 00° 00' 01" WEST, A DISTANCE OF 50.64
24 FEET; THENCE NORTH 89° 59' 55" EAST, A DISTANCE OF 1.00 FOOT TO THE POINT OF
25 BEGINNING;
26 CONTAINING 50.64 SQUARE FEET (0.0012 ACRES), MORE OR LESS
27 be and the same is hereby approved and said real property is hereby laid out and established and
28 declared laid out, opened and established as North Yates Street.

29 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known
30 as North Yates Street.
