**5. General description or background of proposed request.**

In partnership with Denver Climate Action, Sustainability and Resiliency (CASR), Denver Economic Development & Opportunity's Workforce Development Division was awarded a State Opportunity Now grant in the amount of \$1,538,593.00 to increase the education and training capacity for electric vehicle maintenance technicians in the Metro Denver region.

Ohm On The Range was one of 3 educational institutions who received these dollars to enhance and expand automotive training classes with a focus on electric vehicles, charging and maintenance.

This amendment extends the period of performance 7 months through October 31, 2026 and adds \$49,850.00 for a new total of \$504,851.00.

This contract allows Ohm On The Range to serve 90 Denver area youth participants, with a goal to have 76 successful completions and 60 youth who will earn an industry recognized credential.

To date Ohm On The Range has served 24 High School participants with 100% earning EV Voltage Level 1 credential. Ohm On The Range is planning to serve 8 youth participants on a monthly basis through the end of the contract term (Oct, 31 2026) and is currently on track to achieve their contracted performance metrics.
