A RESOLUTION

Approving and providing for the execution of a proposed amended Grant Agreement between the City and County of Denver and the State Board of the Great Outdoors Colorado Trust Fund (GOCO) for the “My Outdoor Colorado” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed amended Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed amended Grant Agreement between the City and County of Denver and the State Board of the Great Outdoors Colorado Trust Fund (GOCO), for the “My Outdoor Colorado” program, a copy of which is duly filed with the City Clerk, Filing No. 202055600, be and hereby is approved in all respects.

Section 2. The payments made by the State Board of the Great Outdoors Colorado Trust Fund to the City pursuant to and under the amended Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 15000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of Parks and Recreation, is as follows:

The foregoing amendment increases the current grant authorization from \$2,700,000 to \$2,760,837.48. Authorization for expenditures of said funds will cover the period from May 26, 2017

1 to December 31, 2021. This amendment also expands the number of youth that will be served for
2 employment opportunities by 20 for a new total of 60.
