A BILL

For an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.

WHEREAS, pursuant to section 9.1.1 (C) and (D) of the Charter and Article I of Chapter 18, D.R.M.C., the Office of Human Resources has recommended to the City Council an amendment to the classification and pay plan governing the compensation of employees in the career service and certain employees not in the career service;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That effective **beginning of the first work week following approval by the Mayor or by the City Council over the Mayor’s veto**, the classification and pay plan is hereby amended by adding the following classifications and pay grades:

<u>Classification Title</u>	<u>Pay Grade & Range</u>
Public Health Administrator	811-E (\$57,464-\$91,942)
Environmental Administrator	813-E (\$65,668-\$105,069)
Senior Environmental Administrator	814-E (\$70,199-\$112,318)

Section 2. That effective **beginning of the first work week following approval by the Mayor or by the City Council over the Mayor’s veto**, the classification and pay plan is hereby amended by abolishing the following classifications and pay grades:

<u>Classification Title</u>	<u>Pay Grade & Range</u>
Senior Environmental Public Health Program Administrator	814-E (\$70,199-\$112,318)
Environmental Public Health Program Administrator	813-E (\$65,668-\$105,069)

2 kept and maintained in the office of the Clerk and Recorder, as reflected at Clerk Filing No. 14-
3 289-M, and at the Office of Human Resources, and shall be available for public inspection both in
