**A BILL**

**For an ordinance making rescissions from the General Fund; making appropriations in the General Fund to make cash transfers; making appropriations the Capital Improvement and Capital Maintenance Fund to address 2022 and 2023 needs.**

**WHEREAS**, Council District Four, wishes to transfer 2022 savings to Capital Improvement and Maintenance Funds to support the Babi Yar Park Rehabilitation project and for Bible Park Art in 2023; and

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
