**A BILL**

**For an ordinance making a rescission from 6 completed or deferred facilities maintenance capital projects and making appropriations to support 7 other priority facility maintenance projects in the City.**

**WHEREAS**, the City wishes to rescind \$1,196,548 in savings from completed facilities capital maintenance projects including roof and window repairs, plumbing and HVAC improvements, alarm system upgrades, and site work; and

**WHEREAS**, said savings will be appropriated to support capital improvements in other key maintenance areas, including supplemental funding to complete HVAC, roof, heating, and cooling system improvements at City branch libraries, roof improvements at the Cherry Creek Campus, and completing the buildout of the bond-funded SWAT team restroom remodel;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Capital Improvements and Capital Maintenance Fund Series, Accounting No. 31000, listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
