6 **For an ordinance establishing a new Fund in the Community Development**  
7 **Special Revenue Fund Series for the “SIPPRA” program.**

9 **WHEREAS**, the Department of Housing Stability wishes to create a new Grant Fund to  
10 administer the Social Impact Partnerships to Pay for Results Act (SIPPRA) Program Grant, a copy  
11 of which is duly filed with the City Clerk, Filing No. 202160100, as well as the SIPPRA Evaluator  
12 Grant, a copy of which is duly filed with the City Clerk, Filing No. 202160102;

13  
14 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
15 **OF DENVER:**

17 **Section 1.** A new fund is hereby established in the Community Development Special Revenue  
18 Fund Series, the “SIPPRA Grant” Fund, Accounting No. 16016, for the purpose of accounting for the  
19 receipt and expenditure of the SIPPRA Program Grant and SIPPRA Evaluation Grant dollars.

20  
21 **Section 2.** Monies received by the United States Department of Treasury to the City pursuant  
22 to and under the SIPPRA Grant Agreements shall be deposited into the Treasury of the City and  
23 credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of  
24 the Revised Municipal Code of the City and County of Denver.

25  
26 **Section 3.** Program expenditures are hereby authorized for the “SIPPRA Grant” Fund,  
27 Accounting No. 16016, in the amount not to exceed the amounts awarded as described in Section 2  
28 of this Ordinance. The expending authority for the Fund is the Executive Director of the Department  
29 of Housing Stability. This Fund is sponsor-based and non-lapsing.

31 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
32 and directed to make such book and record entries and to do such other things as may be necessary  
33 to accomplish the purposes of this Ordinance
