**A BILL**

**For an ordinance making rescissions from multiple agency General Fund budget appropriations to make an appropriation in the Mayor's Office General Fund budget.**

**WHEREAS**, per City Charter, the mayor appoints 50 appointees at his or her discretion; and

**WHEREAS**, budget for these positions historically has been allocated across the City to agencies which have 'nexuses' with the work of specific appointee positions; and

**WHEREAS**, through mayoral transitions and turnover, discrepancies have arisen as each mayor has a workplan which may or may not align with the inherited budget structure of the appointee positions; and

**WHEREAS**, this request is a companion to Ordinance 592, series of 2025; and

**WHEREAS**, the City wishes to move budget associated with all discretionary appointees, except those who lead agencies, into the Mayor's Office budget, per the request of City Council; and

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
