This ordinance seeks to expand the program capacity and transfer an additional \$350,000 to the Down Payment Assistance Special Revenue Fund (11860-2550000) from General Fund Contingency as an <b>administrative mechanism for the financial transactions</b> related to this program. The monies in the fund will be replenished as the resulting GNMA Certificates are delivered.
