4 **A RESOLUTION**

5 **Authorizing submittal of an application for a special-purpose subzone of**  
6 **Foreign-Trade Zone No. 123 for use by Ackerman North America LLC/dba**  
7 **Amann USA and related entities.**

9 **WHEREAS**, the City and County of Denver has received permission from the United States  
10 Foreign-Trade Zones Board (the "Board") to establish, operate and maintain a foreign trade zone  
11 in Denver, Colorado; and

12 **WHEREAS**, the City has acted in the Zone Grantee capacity for Foreign-Trade Zone No.  
13 123 since 1985; and

14 **WHEREAS**, the City and County of Denver, as the Zone Grantee, has applied for and  
15 received permission from the Board to establish subzones of Foreign-Trade Zone No. 123 for use  
16 by companies outside of the City and County of Denver; and

17 **WHEREAS**, the City and County of Denver has received a request to apply to establish a  
18 special-purpose foreign-trade subzone for the exclusive use of Ackerman North America LLC/dba  
19 Amann USA, and other Ackerman North America entities (together, the "Companies"), in the  
20 Denver metropolitan area; and

21 **WHEREAS**, Denver's Office of Economic Development ("OED") has reviewed the request  
22 and has determined that establishment of the new subzone would enhance the Companies' and  
23 Colorado's global competitiveness and attract and retain jobs in Colorado; and

24 **WHEREAS**, the City Council concurs with OED's recommendation and believes that the  
25 City should support the establishment of the subzone; and

26 **WHEREAS**, a resolution of the City Council in support of the establishment of the subzone  
27 application is a requirement of applicable federal law, specifically 15 C.F.R. section 400.24(c);

28 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**  
29 **OF DENVER:**


30 **Section 1.** The City and County of Denver, Colorado hereby authorizes submittal of an  
31 application to the Foreign-Trade Zones Board for authority to establish a special-purpose foreign-  
32 trade subzone for use by the Companies. OED is authorized to send a letter of transmittal of said  
33 application, with or without the City's seal, to the Foreign-Trade Zones Board. Subsequent  
34 administrative actions, including without limitation minor modifications to any Board Order, or

1 expansion of the zone project, may be filed at the Foreign-Trade Zones Board by the Companies  
2 or their representatives without further action of the Denver City Council.
