6 **For an ordinance establishing a new Fund in the General Government Special**
7 **Revenue Fund Series for the “DOJ Settlement ADA Improvements” program.**

9 **WHEREAS**, during 2020, the City entered into supplemental negotiations with the U.S.
10 Department of Justice under Project Civic Access (PCA) to improve accessibility for individuals
11 with disabilities; and

12 **WHEREAS**, Companion Ordinance 21-1308 includes a \$2 million rescission from General
13 Fund agencies to transfer cash to a new, non-lapsing Fund to support operating costs to
14 administer ADA projects required under the PCA agreement;

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
17 **OF DENVER:**

19 **Section 1.** A new Fund is hereby established in the General Government Special Revenue
20 Fund Series, Accounting No. 11000, a “DOJ Settlement ADA Improvements” Fund, Accounting No.
21 11884, for the purpose of accounting for the receipt and expenditure of program dollars.

22 **Section 2.** Monies received from General Fund transfers for Accounting No. 11884 shall be
23 deposited into the Treasury of the City and credited to Special Revenue Fund No. 11000, which is
24 set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of
25 Denver.

26 **Section 3.** Program expenditures are hereby authorized for the “DOJ Settlement ADA
27 Improvements” Fund, Accounting No. 11884, to be expended by the Executive Director of General
28 Services. Allowable expenses include the operating costs to administer ADA projects required under
29 the DOJ settlement. The Chief Financial Officer may transfer unused balances in the Fund to the
30 General Fund. This Fund is appropriated and non-lapsing.

31 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
32 and directed to make such book and record entries and to do such other things as may be necessary
33 to accomplish the purposes of this Ordinance.
