9 For an ordinance authorizing expenditures in the Bond Projects fund for the  
10 Colorado Convention Center Interior Improvements project.

12 WHEREAS, the 1999 bond-funded Colorado Convention Center Expansion project is  
13 complete; and

14 WHEREAS, there remains a cash balance from the interest earned of \$79,601.76; and

15 WHEREAS, the City and County of Denver desires to use the interest earnings for capital  
16 projects to build out the last remaining unfinished space at the Convention Center;

18 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY  
19 OF DENVER:

20 Section 1. Expenditures are hereby authorized from the Bond Projects Fund, Accounting  
21 No. 36000, the amounts of money in the following tabulation to be expended for the purposes  
22 and upon the authorizations in said Ordinance set forth:
