A BILL

For an ordinance approving and providing for the execution of a proposed contract between the City and County of Denver and The Greenway Foundation, concerning the "River Vision Implementation Plan-TGF" project and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed contract;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed contract between The Greenway Foundation and the City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 13-249, be and hereby is approved in all respects.

Section 2. The payments made by The Greenway Foundation to the City pursuant to and under the contract shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said project is as follows:
