9 **For an ordinance approving and providing for the execution of a proposed**
10 **Intergovernmental Agreement between the City and County of Denver and the**
11 **State of Colorado, Department of Transportation, concerning the "Traffic Signal**

14 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
15 Intergovernmental Agreement;

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**

20 **Section 1.** The proposed Intergovernmental Agreement, under CFDA No. 20.205, between
21 the State of Colorado, Department of Transportation, and the City and County of Denver, a copy of
22 which is duly filed with the City Clerk, Filing No. 14-0066, be and hereby is approved in all
23 respects.

24 **Section 2.** The payments made by the Colorado Department of Transportation to the City
25 pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of
26 the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18
27 of the Revised Municipal Code of the City and County of Denver.

28 **Section 3.** That it be and is hereby found and determined that the budget summary of said
29 "2014 Traffic Signal Upgrade-Safety Hazard Elimination" project is as follows:
