FIRST AMENDATORY AGREEMENT

THIS FIRST AMENDATORY AGREEMENT is entered into as of the date indicated on the City signature page below, by and between the **CITY AND COUNTY OF DENVER**, a Colorado municipal corporation ("City"), Party of the First Part, and, **WOOLPERT, INC.**, an Ohio corporation authorized to do business in Colorado ("Consultant"), Party of the Second Part.

WITNESSETH

WHEREAS, the parties entered into an Agreement dated June 8, 2010 ("Existing Agreement") wherein the Consultant agreed to provide certain professional planning services to the City's Department of Aviation; and

WHEREAS, the parties desire to amend the Existing Agreement to extend the Term;

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

1. **Section 5 of the Agreement, entitled "Term,"** is hereby amended and restated to read as follows:

The term of this Agreement shall commence on June 8, 2010, and terminate on December 31, 2013, unless it is terminated sooner in accordance with the terms and conditions of this Agreement.

2. Except as otherwise provided herein, all of the terms, provisions, and conditions of the Existing Agreement shall remain in full force and effect as though set out in full here, and are hereby ratified and reaffirmed.
3. This First Amendatory Agreement shall not be effective or binding on the City until fully executed by all signatories of the City and County of Denver.
