5 **A BILL**

6 **For an ordinance authorizing a capital equipment purchase in the Planned**  
7 **Fleet Special Revenue Fund.**

9 **WHEREAS**, Ordinance No. 1284, Series of 2021, the Annual Appropriation Ordinance,  
10 authorized the 2022 spending allocation in the Planned Fleet Special Revenue Fund; and

11 **WHEREAS**, said allocation includes an appropriation to support the purchase of four  
12 vehicles for the Early Intervention Team (EIT); and

13 **WHEREAS**, due to projected savings within the Planned Fleet SRF there are funds  
14 available to purchase an additional vehicle for the EIT; and

15 **WHEREAS**, said vehicle is over the \$50,000 threshold for capital equipment items that  
16 require City Council approval, per the Denver Revised Municipal Code; and

17 **WHEREAS**, this bill request authorizes the purchase of said vehicle;

19 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
20 **OF DENVER:**

22 **Section 1.** From the Denver Planned Fleet Special Revenue Fund, Accounting No. 11804, the  
23 Executive Director of the Department of Housing Stability, or duly authorized representatives, is  
24 hereby authorized to purchase or acquire the following capital equipment:
