**A BILL**

**For an ordinance making an appropriation in the Wastewater Management Enterprise Fund.**

**WHEREAS**, ordinance 0921, series of 2023 approved a proposed Second Amendment to the Intergovernmental Agreement No. 21-05.14A between the City and County of Denver and Urban Drainage and Flood Control District, d/b/a Mile High Flood Control District (MHFD), for continued design and construction of drainage and flood control improvements for Marston Lake North at Bowles Ditch; and

**WHEREAS**, said amendment increases the total contract amount by \$1,500,000, (\$750,000 from MHFD and \$750,000 from the City and County of Denver), for a new total of \$6,000,000; and

**WHEREAS**, the City will invoice the MHFD for reimbursement after construction is complete; and

**WHEREAS**, additional appropriation is required to administer payments to MHFD for the City's portion of the construction; and

**WHEREAS**, to date, \$5,000,000 has been appropriated to support the IGA; therefore, an additional ordinance is required to appropriate the remaining \$1,000,000;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Wastewater Management Enterprise Fund, Accounting No. 72000, out of monies not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1146, Series of 2022, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:

4 agreement with the Urban Drainage Flood Control District for drainage and flood control  
5 improvements for Marston Lake North at Bowles Ditch.
