This ordinance amendment adds language to reflect current state law with regard to child restraint requirements in motor vehicles. For example, the state traffic code formerly required child restraint systems (i.e. car seats and/or booster seats) for children who are under four years of age or less than 40 pounds in weight, but was amended in 2010 to require restraint systems for all children under the age of eight. The stricter requirements of the state traffic code are fully operative in Denver at present, but city ordinances should be amended to conform to the state law so there is no public confusion about the requirements for child safety restraints in Denver.
