6 7 8	For an ordinance naming an unnamed park at Kittredge St. and E. Bollinger Dr. "Amache Prowers Memorial Park".			
9	WHEREAS, the City and County of Denver entered into an agreement with Denver			
10	Connection West Metropolitan District ("District") to share in the cost of the construction and			
11	development of the unnamed park at approximately Kittredge St. and E. Bolling Dr., Denver,			
12	Colorado 80239; and			
13	WHEREAS, recognizing that the District had no prior obligation to make any contribution to			
14	the construction and development of the park, the Department of Parks and Recreation has			
15	accepted the District's generous contribution as a gift of the park to the City; and			
16	WHEREAS, in accordance with the procedure established by the Department of Parks and			
17	Recreation's Naming Policy, the Executive Director of the Department of Parks and Recreation			
18	submitted a proposal to the Parks and Recreation Advisory Board to name the park "Amache			
19	Prowers Memorial Park"; and			
20	WHEREAS, the purpose of the naming is to honor the indigenous activist and advocate			
21	Amache Prowers; and to honor her work as a mediator between Colorado territorial settlers,			
22	Mexicans and Native Americans in the mid to late 19th century. This park would be a tribute to her			
23	dedication to the cultural understanding, community leadership and role in shaping Colorado; and			
24	WHEREAS, the Executive Director of the Department of Parks and Recreation supports the			
25	proposed naming of this park; and			
26	WHEREAS, the Department of Parks and Recreation further supports the District's request			
27	to name the park "Amache Prowers Memorial Park" in recognition of the District's gift; and			
28	WHEREAS, the Denver Parks and Recreation Advisory Board voted at its meeting on			
29	September 10, 2025, to recommend the naming of the unnamed park as "Amache Prowers			
30	Memorial Park".			
31	BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:			
32	Section 1. That the park, the same is hereby named, and shall be known as, AMACHE			
33	PROWERS MEMORIAL PARK.			

Section 2. That this action shall be effective upon the final adoption of the ordinance.
