# Denver Performing Arts Complex, Denver Arts & Venues August 2018-Present

The Arts Complex houses ten performance spaces on its four-block, 12-acre site, including the historic Ellie Caulkins Opera House, Temple Hoyne Buell Theatre, and Boettcher Concert Hall. The Arts Complex is home to four resident companies: Colorado Ballet, Colorado Symphony, Opera Colorado and the Denver Center for the Performing Arts which offers Broadway shows, Tony award winning theatre, cabaret and experimental productions. The annual budget for the Arts Complex is \$13 million.

The Venue Director is the senior management position responsible for the operation of the Arts Complex, including venue operations and facility management. The position reports to the Deputy Director of Arts & Venues for the City and County of Denver.

### Key responsibilities include:

- Lead team toward vision of Arts Complex that aligns with Agency goals and mission. Communicate vision and guidance to all team members. Provide management of Arts Complex productions, facilities and operations.
- Provide leadership, vision and coordination of public programs, including budget development and program goals.
- Engage in collaborative programming opportunities with Resident Companies.
- Work with Arts & Venues Finance to develop and manage annual budget, including operations, P/L, capital, and maintenance budgets.
- Provide leadership and management of capital improvement projects.
- Work with Arts & Venues Marketing to advance facility and program marketing goals.
- Maintain strong relations with all presenting partners and resident companies.
- Collaborate, initiate and/or lead various Agency initiatives including diversity, equity and inclusiveness programs and patron accessibility.
- Assess and implement enhanced security measures at Arts Complex.

The annual budget for the Palace League is \$1.5MM. The position reports to the Board of Directors.

# David H. Koch Theater at Lincoln Center, New York, NY Sept 2003-April 2015

City Center of Music and Drama, Inc. (CCMD), a constituent of Lincoln Center for the Performing Arts, managed the David H. Koch Theater. The theater is home to the New York City Ballet and was the former home of the New York City Opera. Prior to the merger with NYCB in 2017, the operating budget of CCMD was \$12 million.

The Managing Director was the chief executive officer for CCMD, overseeing the operations of the David H. Koch Theater. The position reported to the Board of Governors of City Center of Music and Drama, Inc.

- Works to promote a healthy working relationship with union and non-union personnel; leads in contract negotiations for collective bargaining agreements.
- Develops and implements a master plan for the continual upkeep, maintenance and improvement of the David H. Koch Theater.
