17 **Section 1.** Date, Time, and Location of Public Hearing for Metropolitan Districts. The City

19 Business Improvement District and the initial Operating Plan and preliminary 2016 Budget. The  
20 public hearing shall be on the 1st day of June, 2015, at 5:30 p.m. in Council Chambers in the City  
21 and County Building located at 1437 Bannock Street, in Denver, Colorado.

22 **Section 2.** Other Notices. The proponents of the district shall give any statutorily required  
23 notices.

24 **Section 3.** That the Clerk of the City and County of Denver shall attest and affix the seal  
25 of the City and County of Denver to this Resolution.
