**A BILL**

**For an ordinance making an appropriation from the Wastewater Enterprise Fund to accompany the agreement between the City and County of Denver and Taubman-Cherry Creek Limited Partnership for the University/Josephine street and sewer project**

**WHEREAS**, the City and County of Denver entered into a companion agreement with Taubman-Cherry Creek Limited Partnership to upsize a storm sewer at no cost to the City and abandon a permanent easement as part of the University/Josephine street and sewer project (ordinance number 0196, Series of 2014), and

**WHEREAS**, funds for this expenditure will come from Taubman-Cherry Creek Limited Partnership; and

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Wastewater Enterprise Fund, Accounting No. 72000, out of monies not otherwise appropriated and in addition to the amounts heretofore appropriated by Ordinance No. 631, Series of 2013, and any supplemental appropriations or rescissions there is hereby appropriated to the appropriation account hereinafter designated the amounts of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
