6 **A RESOLUTION**

7 **Approving and providing for the execution of a proposed Grant Agreement**  
8 **between the City and County of Denver and Colorado Department of**  
9 **Transportation (CDOT) for the Central 70 Artwork Program.**

11 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
12 Grant Agreement;

13  
14 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**  
15 **OF DENVER:**

17 **Section 1.** The proposed Grant Agreement, between the City and County of Denver and the  
18 Colorado Department of Transportation (CDOT), to receive funding for the Central 70 Artwork  
19 Program, which is identified as Grant Number 22-HAA-XC-00008, a copy of which is duly filed with  
20 the City Clerk, Filing No. 20216033, be and hereby is approved in all respects.

21 **Section 2.** The payments made by the Colorado Department of Transportation to the City  
22 pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and  
23 credited to Special Revenue Fund No. 38000, which is set forth and described in Section 20-18 of  
24 the Revised Municipal Code of the City and County of Denver.

25 **Section 3.** That it be and is hereby found and determined that the budget summary of said  
26 program, to be expended by the Executive Director of Denver Arts and Venues, is as follows:

29 The foregoing is to provide the City and County of Denver with a grant to supply public artwork for  
30 the Colorado Department of Transportation’s Central 70 Project. Procurement and selection of Art  
31 will be in accordance with the City of Denver Public Art Ordinance and Policy and final works will

1 become property of the City and County of Denver and be added to the City's permanent public art  
2 collection. Authorization for expenditures of said funds will cover the period from June 1, 2022 to  
3 January 27, 2027.

5 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
6 and directed to make such book and record entries and to do such other things as may be necessary  
7 to accomplish the purposes of this Resolution.
