11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

13 Section 1. That effective January 1, 2016, Chapter 18, Article IV, Section 18-101 of the
14 Revised Municipal Code is hereby amended to read as follows:

16 Sec. 18-101. Deputy sheriff major, deputy sheriff division chief, and sheriff pay plans.

43 Section 2. That effective January 1, 2016, Chapter 18, Article IV, Section 18-114 of the
44 Revised Municipal Code is hereby amended to read as follows:

46 Sec. 18-114. Acting pay.

1 Effective January 1, ~~2015~~ **2016**, a deputy sheriff division chief who, for a period of eight (8)
2 consecutive work hours or more, is temporarily assigned to act as the sheriff shall be
3 compensated at the rate of pay of the sheriff, in lieu of the salary of deputy sheriff division chief,
4 for such time assigned to act as the sheriff; and, a deputy sheriff major who, for a period of eight
5 (8) consecutive work hours or more, is temporarily assigned to act as a deputy sheriff division
6 chief shall be compensated at the pay rate of deputy sheriff division chief, in lieu of the salary of
7 deputy sheriff major, for such time assigned to act as a deputy sheriff division chief. ~~In either such~~
8 ~~case, the applicable pay rate (1) a nine and one-half percent (9.5%) increase above the~~
9 ~~individual's existing pay rate as a deputy sheriff division chief or deputy sheriff major, or (2) the~~
10 ~~salary range minimum for the higher rank, whichever is greater.~~
