A BILL

For an ordinance approving a proposed Development Project Funding Agreement (Denver Pavilions located at 500 16th Street, Denver, Colorado) between the City and County of Denver and Denver Downtown Development Authority, in Council District 10.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Intergovernmental Agreement between the City and County of Denver and Denver Downtown Development Authority, in the words and figures contained and set forth in that form of agreement available in the office and on the web page of City Council, and filed in the office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, under City Clerk's Filing No. 202581850, is hereby approved.

Section 2. This proposed Ordinance shall only be effective upon: 1) Council's approval, and the legal effectiveness, of Ordinance No. 914, Series of 2025 in accordance with Section 3.3.5 of the City Charter; and 2) the successful closing of the financial transactions contemplated in accordance with Ordinance No. 914, Series of 2025 to provide sufficient appropriated funding for the transaction contemplated in this Ordinance in conformance with Section 7.2.2 of the City Charter. If both of the conditions precedent referenced in the previous sentence are not fully satisfied by **December 19, 2025**, then this Ordinance shall be of no legal force or effect and shall be void *ab initio*."
