The Crime Prevention and Control Commission received a SAMHSA grant to provide high fidelity wrap around treatment services to persons with co-occurring mental health and substance abuse issues enrolled in Denver Drug Court. The original grant time frame was three years, FY 10/1/2009 - 9/29/2012. The revised contract extends that time period to end, July 29, 2013. A total of \$284,933 annually and \$854,799 over the life time of the grant. Grant funds are subcontracted to The Mental Health Center of Denver \$602,799 over the life time of the grant FY 10/1/2009 –7/29/2013.
