**A BILL**

**for an Ordinance approving a proposed purchase by the City and County of Denver of insurance coverage from: Kaiser Permanente Health Plan of Colorado; United Healthcare; Denver Health Medical Plan, Inc.; Delta Dental of Colorado, Standard Insurance Company of Colorado, Inc., and; Anthem Blue Cross and Blue Shield.**

**WHEREAS**, pursuant to Section 18-5(c), Denver Revised Municipal Code, the Career Service Authority Director of Personnel has consulted with the employee health insurance committee and recommends to City Council the following employee benefit changes to the insurance policies and agreements between the City and entities set forth below.

**WHEREAS**, pursuant to Section 18-5(c), DRMC, City Council may accept, reject or modify any benefit recommendations made by the Director.

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed purchase of insurance coverage by the City and County of Denver from **Kaiser Health Plan of Colorado (“Kaiser”)**, in the words and figures contained and set forth in the Rate Sheets, Benefit Proposals, and 2013 Health Plan Benefit Forms as filed in the Office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, on the 20<sup>th</sup> day of September, 2012, **City Clerk's Filing No. 12-0726** (for Career Service (“**CCD**”), Denver Police Department (“**DPD**”) and other eligible persons) attached hereto, is hereby accepted.

**Section 2.** The proposed purchase of insurance coverage by the City and County of Denver from **United Healthcare (“United”)**, in the words and figures contained and set forth in the Rate Sheets, Summary of 2013 Benefits, and 2013 Health Plan Description Forms as filed in the Office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, on the 7<sup>th</sup> day of September, 2012, **City Clerk's Filing No. 12-0727** (CCD, DPD and other eligible persons) attached hereto, is hereby accepted.

**Section 3.** The proposed purchase of insurance coverage by the City and County of Denver from **Denver Health Medical Plan, Inc. (“Denver Health”)**, in the words and figures contained and set forth in the Draft Rate Sheets, Summary of 2013 Benefit Changes, and

4 **Section 4.** The proposed purchase of dental insurance coverage by the City and County  
5 of Denver from **Delta Dental of Colorado**, in the words and figures contained and set forth in the  
6 Health Plan Description Forms and Rate Sheets (for Retirees), and Memorandum of  
7 Understanding (For CCD) as filed in the Office of the Clerk and Recorder, Ex-Officio Clerk of the  
8 City and County of Denver, on the: 8<sup>th</sup> day of September, 2011, **City Clerk's Filing No. 11-739**,  
9 and **City Clerk's Filing No. 11-740** for retired classified members of DPD and other eligible  
10 persons, and; 3<sup>rd</sup> day of February, 2011, **City Clerk's Filing No. 09-130-B** (CCD and other eligible  
11 persons) attached hereto, are hereby accepted.

12 **Section 5.** The proposed purchase of insurance coverage for basic life, accidental death  
13 and dismemberment, and long term disability insurance by the City and County of Denver from  
14 **Standard Insurance Company of Colorado, Inc.**, in the words and figures contained and set  
15 forth in the benefit summaries as filed in the Office of the Clerk and Recorder, Ex-Officio Clerk of  
16 the City and County of Denver, on the 8th day of September, 2011, **City Clerk's Filing No. 11-**  
17 **0738** (CCD, DPD and other eligible persons) attached hereto, is hereby accepted.

18 **Section 6.** The proposed purchase of insurance coverage for vision insurance by the City  
19 and County of Denver from **Anthem Blue Cross and Blue Shield**, in the words and figures  
20 contained and set forth in the benefit summaries as filed in the Office of the Clerk and Recorder,  
21 Ex-Officio Clerk of the City and County of Denver, on the 10<sup>th</sup> day of September, 2012, **City**  
22 **Clerk's Filing No. 11-978** (CCD, DPD and other eligible persons) attached hereto, is hereby  
23 accepted.

24 **Section 7.** The Career Service Authority Director of Personnel, and the Human Resources  
25 Director of the Denver Police Department are hereby authorized to perform all of the duties and  
26 undertake all of the responsibilities needed to effectuate the insurance policies and agreements  
27 between the City and entities set forth above in this ordinance, as contemplated by and consistent  
28 with this ordinance.
