**A BILL**

**For an ordinance making supplemental appropriations from the General Contingency Fund to Police and Sheriff departments.**

**WHEREAS**, the City desires to increase the security presence on the 16<sup>th</sup> Street Mall, LoDo and the Ballpark neighborhood; and

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**
