6. General description of proposed ordinance including contract scope of work if applicable:

This ordinance request is to amend Chapter 18 of the Revised Municipal Code to establish the 2016 and 2017 salary of the Sheriff, Division Chiefs and Majors.

The proposed increase mirrors the collective bargaining agreement (CBA) with the Fraternal Order of Police – Denver Sheriff Lodge 27. The CBA instituted a pay increase of 3.25% in 2016 and an increase of 3% in 2017. A 3.25% increase for the command staff equates to approximately a \$25,500 budget increase and a 3% increase in 2017 equates to approximately \$24,000.

Additionally, this ordinance seeks to eliminate the range for the Command Staff to mirror the command pay ordinances of the Police and Fire Department. The charter was changed in 2013 allowing the Sheriff to appoint Division Chiefs and Majors, with the approval of the Executive Director. This ordinance request also seeks to set the pay for Division Chiefs appointed on or after February 1, 2016 to reflect the Sheriff's new organizational structure.
