General description of proposed ordinance including contract scope of work if applicable: Intergovernmental Agreement (IGA) between Greenwood Village, Arapahoe County and the City and County of Denver for the sharing of the cost of studying and designing certain roadway improvements at the Interstate 25 (I-25) and Bellevue interchange. The phrase “studying and designing” refers to the NEPA environmental process that will be conducted to identify a preferred alternative design for the I-25/Bellevue interchange. An Environmental Assessment will be prepared based on preliminary design, and will include a public input process, identifying potential impacts and mitigation measures.

Both CDOT and FHWA will have to approve the EA and FONSI before the project can proceed into final design and for funding purposes, so those phases are not included in this initial phase covered by the IGA.
