The ordinance will approve an amendment of the intergovernmental agreement between the City and Denver Health and Hospital Authority for the construction of the DHHA South Westside Clinic (known as South West Clinic) located at 1339 S. Federal Boulevard that has been in effect since January 1, 2014. The amendment will reflect new funding levels, an extended term and other necessary adjustments for 2015. The City’s planned combined contribution totals \$22,150,000 over a thirty (30) year period. The combined contribution over the 30 year term is subject to annual appropriation and is comprised of the following sources:

- \$1,400,000 from Better Denver Bond funding approved via a companion ordinance in 2011.
- \$13,250,000 from the Capital Improvement Fund
- \$7,500,000 from the General Fund

The City’s payment included in the 2015 budget totals \$700K.
