This resolution is to approve the use of grant funds awarded from CDOT to DEN for the use in procuring and installing (5) new Customer Service Booths in all three concourses and the Great Hall at DEN. The new information booths will meet the functional requirements set by DEN Customer Service including storage, technology, and with aesthetics that align with the DEN vision, brand, philosophy, and design principles, as well as meet all current design and all ADA accessibility standards. This solution will allow for better customer service for passengers at DEN.

Funding DEN CIP Match = \$200,000 & CDOT Grant = \$800,000.

The Grant also funds (2) new information booths for the Great Hall Renovations. All of the Passenger Information Booths will be equipped with the latest in technology.
