A BILL

**For an ordinance making an appropriation within the Denver Arts and Venues
Special Revenue Fund.**

WHEREAS, the City desires to provide additional funding to Denver Arts and Venues for expenditures related to increased number of events;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the Cultural and Recreation Special Revenue Fund, Accounting No. 15000, out of monies not otherwise appropriated and in addition to the amounts heretofore appropriated by Ordinance No. 699, Series of 2014, and any supplemental appropriations or rescissions there is hereby appropriated to the appropriation account hereinafter designated the amounts of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:

The foregoing is to appropriate funds for increased expenditures due to increased number of events over those budgeted. The increased expenditures will be offset by increased revenues to the Denver Arts and Venues Special Revenue Fund.
