**A BILL**

For an ordinance making a rescission from General Fund Contingency, making a supplemental appropriation to the Denver Police Department, making appropriations in the General Fund to make cash transfers to the Capital Improvements and Capital Maintenance Fund, and making a supplemental appropriation in the Environmental Services Enterprise Fund.

**WHEREAS**, the Denver Police Department requests \$3,700,000 to cover the cost of several anticipated expenditures including backfilling with overtime as a result of being below authorized strength, an increase in lateral recruits, and leave payouts; and

**WHEREAS**, Technology Services requests \$1,350,000 to cover one-time investments in city modernization, application portfolio consolidation, and asset management to protect city systems, reduce technical debt, and generate savings; and

**WHEREAS**, the Department of Finance requests \$1,146,000 for the construction and renovation of 405 South Platte to support the Child Welfare “in order” process, which is being located from the Denver Human Services campus; and

**WHEREAS**, the Denver Department of Public Health and Environment requests \$250,000 be Environmental Services Enterprise Fund to cover 2019 pay survey increases that were not adequately budgeted;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
