## DESIGNATING MAY 18 THROUGH MAY 24 AS "PUBLIC WORKS WEEK IN DENVER" AND CONGRATULATING THE DENVER DEPARTMENT OF TRANSPORTATION AND INFRASTRUCTURE'S EMPLOYEES OF THE YEAR FOR 2024

**WHEREAS**, in celebrating the American Public Works Association's 2025 theme of "People, Places, and Presence", we recognize the employees of Denver's Department of Transportation and Infrastructure (DOTI) as "ever-present" in our communities, improving safety, mobility, infrastructure, and quality of life; and

**WHEREAS**, the department seeks continuous improvement and to implement innovations that deliver work effectively and equitably and is celebrating that its Solid Waste and Wastewater Management divisions have been officially accredited by the American Public Works Association, celebrating their alignment with industry best practices; and

**WHEREAS**, the APWA specifically recognized DOTI for model practices around community participation and engagement, waste education, and its safety recognition program; and

WHEREAS, safety is the cornerstone of all the programs, services and initiatives that DOTI delivers and the department is working to make travel in our city safer with treatments that slow vehicle speeds and protect vulnerable roadway users; and
