

FIRST AMENDATORY AGREEMENT

THIS FIRST AMENDATORY AGREEMENT is entered into as of the date indicated on the signature page, by and between the **CITY AND COUNTY OF DENVER**, a Colorado municipal corporation ("City"), Party of the First Part, and **IED SUPPORT SERVICES, LLC d/b/a IED ON CALL**, a Delaware limited liability company (the "Consultant"), Party of the Second Part;

WITNESSETH

WHEREAS, the parties entered into an Agreement dated March 22, 2012 (the "Existing Agreement") in which the Consultant agreed to provide software professional services and replacement parts, warranty, hardware and other software services for the maintenance and operation of the Voice Paging System ("VPS") at Denver International Airport; and

WHEREAS, the parties desire to amend the Existing Agreement by increasing the Maximum Liability and Term of the Agreement; and

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

1. Section 4 **MAXIMUM CONTRACT LIABILITY; FUNDING** is hereby amended by deleting Section 4 in its entirety and replacing it with the following:

“4. MAXIMUM CONTRACT LIABILITY; FUNDING:

Any other provision of this Agreement notwithstanding, in no event shall the City be liable for payment of services rendered and expenses incurred by the Consultant, including the fee set forth above and any additional services requested and authorized by the City, under the terms of this Agreement for any amount in excess of Seven Hundred Ninety Six Thousand Nine Hundred Seventy Nine Dollars and Zero Cents (\$796,979.00). The Maximum Contract Liability may only be increase by amendment to this Agreement.”

2. Section 5 **TERM** is hereby amended by deleting Section 5 in its entirety and replacing it with the following:

“5. TERM:

The term of this Agreement shall commence on the Effective Date, and shall terminate March 1, 2021 unless sooner terminated. The Term of this Agreement may only be increased by amendment to this Agreement.”

3. Except as otherwise provided herein, all of the terms and conditions of the Existing Agreement shall remain in full force and effect as though set out in full herein.

4. This First Amendatory Agreement shall not be effective or binding on the City until fully executed by all signatories of the City and County of Denver.
