SECOND AMENDMENT TO AIRPORT USE AND FACILITIES LEASE AGREEMENT

This Second Amendment to Airport Use and Facilities Lease Agreement is made and entered into as of date described on the signature page, by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado ("the City"), and MESA AIRLINES, INC., a corporation organized and existing under and by virtue of the laws of the State of Arizona, and authorized to do business in the State of Colorado ("Airline").

WHEREAS, the City and Airline have previously entered into an Airport Use and Facilities Lease Agreement at Denver International Airport ("DIA"), dated November 10, 2004 and amended on April 29, 2008 ("Existing Agreement");

WHEREAS, City and Airline desire to modify the Existing Agreement to create an amended agreement ("Amended Agreement");

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements, herein contained, City and Airline do hereby mutually undertake, promise and agree, each for itself and its successors, as follows:

1. Paragraph 6.01, "TERM OF AGREEMENT," of the Existing Agreement is deleted in its entirety and replaced with the following:

"The term of this Agreement shall commence on May 1, 2002 and shall terminate at Noon MST on December 31, 2011, unless this Agreement is earlier cancelled, terminated or extended as hereinafter provided."

- Except as otherwise modified or amended herein, all terms and conditions of the Existing Agreement shall remain in full force and effect as though set out in full herein.
- 3. This Second Amendment to Airport Use and Facilities Lease Agreement, which is expressly subject to and shall not be or become effective or binding on the City until approved by the Denver City Council and fully executed by all signatories of the City, may be signed in counterparts each of which shall be deemed to be an original signature page of this Agreement.
