**A RESOLUTION**

**Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the U.S. Department of Housing and Urban Development concerning the “HOME Investment Partnerships” program and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement, under Assistance Listing No. 14.239, between the City and County of Denver and the U.S. Department of Housing and Urban Development, for the “HOME Investment Partnerships” program, which is identified as Grant Number M25MC080204, a copy of which is duly filed with the City Clerk, Filing No. 202683320, be and hereby is approved in all respects.

**Section 2.** The payments made by the U.S. Department of Housing and Urban Development to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Department of Housing Stability, is as follows:

The foregoing authorization will fund the City’s housing, business, and neighborhood development activities to provide decent and affordable housing to lower-income households, expand the capacity of nonprofit housing providers, and strengthen the ability of state and local governments to provide

1 housing and leverage private-sector participation. The award amount includes a cost sharing  
2 requirement, which is determined by the type of eligible costs and fulfilled through other non-federal  
3 housing programs, such as the Housing Incentive Program (IHO) and through Private Activity Bonds.  
4 Expenditures are authorized for the period of January 29, 2026, to September 30, 2034.

6 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
7 and directed to make such book and record entries and to do such other things as may be necessary  
8 to accomplish the purposes of this Resolution.
