6. General description/background of proposed ordinance including contract scope of work if applicable:

Amendment No. 11-10.02B. This agreement is to fund the Final Design, Right-of-Way Acquisition and Construction of Drainage and Flood Control Improvements along First Creek at East 56th Avenue. The Amendment will add \$400,000 in CCD and UDFCD funds (split 50/50) to the project. Including this amended amount, the new total agreement amount is \$6,400,000. The project will construct flood control improvements to restore First Creek to a more natural configuration and provide channel capacity for the 100-year floodplain. This project will also acquire the rights to the channel and provide a maintenance path. Project funding includes RTD (FTA funding), DIA, adjacent property owners, and the UDFCD.
